**ASSUMPTION OF THE RISK AND WAIVER LIABILITY RELATING TO CORONAVIRUS/  
COVID-19**

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. **COVID-19 is extremely contagious** and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

**The Academy of Dance Arts ( ADA)** has put in place preventative measures to reduce the spread of COVID-19; however, ADA **cannot guarantee** that you or your child(ren) will not become infected with COVID-19. Further, **attending ADA studio or classes could increase** your risk of contracting COVID-19.

On my behalf, or on behalf of my child(ren), I hereby release, covenant not to sue, discharge, and hold harmless The Academy of Dance Arts, its owners, employees, agents, and representatives, of and from the Claims, including, all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of The Academy of Dance Arts, its owners, employees, agents, and representatives, whether a COVID- 19 infection occurs before, during, or after participation in any ADA program on site and off site or visit to ADA facility.

While our policies are designed to make the Academy a safer space to help protect all, **The Academy of Dance Arts** including all staff, cannot remove all risk or otherwise guarantee or promise that you will not sustain any injuries or damages from viruses, communicable diseases, or other health hazards associated with your use of **ADA's** premises, services, facilities, equipment, activities or products, including exposure, transmission, infection, illness, sickness, disease or death with respect to COVID-19 and the virus that causes it, SARS-CoV-2.
